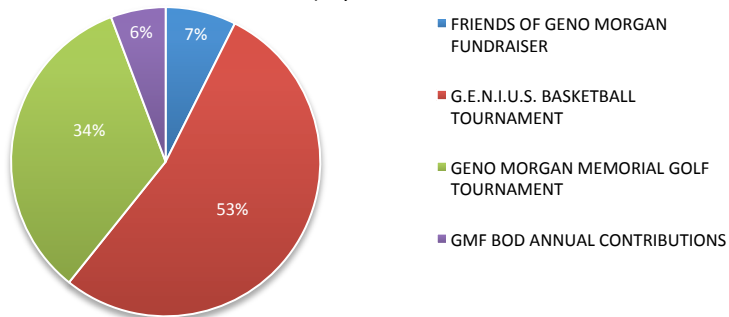
2018 FINANCIAL HIGHLIGHTS

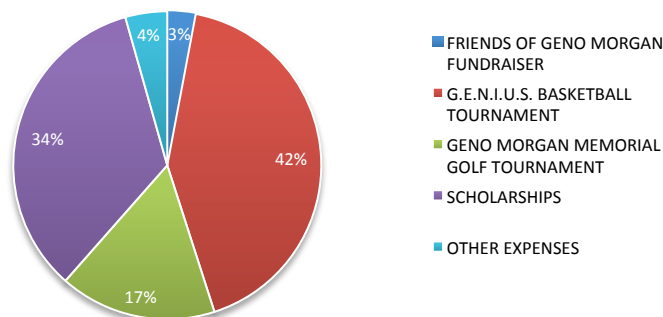
